Les Schultzel, husband of the late Lynn Schultzel, presented the award to Barton for her outstanding work on behalf of at-risk children both in our community and statewide. Barton has served on the Juvenile Justice Board, Collier County Juvenile Justice Council, Juvenile Assessment Center Advisory Board, and PACE Center for Girls State Board, as well as many others. She currently serves on several of the fore mentioned.
